## CHELSEA PIERS CONNECTICUT LLC. PARTICIPANT WAIVER, RELSEASE AND INDEMNITY AGREEMENT

Nature and Scope of Risk Participant acknowledges that participating in Health, Wellness, Sport Expo's Billy Blanks Jr. Dance It Out and/or Captain Saam's Scuba Class at Chelsea Piers Connecticut entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to participants, to property or to third parties.
- 2. Assumption of Risk Participant expressly agrees and promises to accept and assume all of the risks associated with Dance It Out and Scuba. Participant's participation in this activity is purely voluntary, and Participant elect to participate regardless of all risks, known and unknown.
- 3.
